

Subject: Disaster Risk Reduction and Management in the Arab Region

I would like to thank the Arab Academy for Science, Technology and Maritime Transport (AASTMT), and its team for its leadership in advancing the disaster risk reduction and management agenda in the Arab region. Since 2008, our collaboration has enabled several joint risk reduction related activities. These are summarized below along with proposed next steps for additional areas of collaboration amongst us:

 Study on Climate Change Adaptation and Natural Disaster Preparedness in the Coastal Cities of North Africa;

Since 2008, the Bank has supported an ongoing regional study for Egypt, Morocco and Tunisia entitled Climate Change Adaptation and Natural Disaster Preparedness in the Coastal Cities of North Africa. Recently, the World Bank and the AASTMT signed a Memorandum of Understanding (MoU), for the development of an additional study, Climate Change Adaptation and Natural Disaster Preparedness in Greater Alexandria. The Arab Academy has contributed the equivalent of \$200,000 towards the implementation of the Alexandria study. The overall study should be completed by December 2010 and will be disseminated in the region.

(2) Damage and Loss Assessment (DALA) Training:

The Global Facility for Disaster Reduction and Recovery (GFDRR) delivered a post-disaster Damage and Loss Assessment (DALA) Workshop on 26-29 April 2010 as well as a workshop on Risk Assessment on May 2, 2010, both in Cairo. The main objective of the DALA workshop was to establish a core group of AASMT affiliated Arabic speaking experts from the region to undertake future damage, loss and needs assessment in affected countries. Later this year, GFDRR will support a Train the Trainers session in Alexandria,

(3) South-South Cooperation Program:

The AASTMT and the Arab Network for Environment and Development (RAED), in partnership with the Ministries of Environment of Egypt, Tunisia, and with the University of Djibouti, will implement the South-South Cooperation Program (US\$ 300,000) that was approved by GFDRR to undertake risk assessment, and design mechanisms to increase the resilience of communities to risks from disaster and climate change.

The South-South Partners will meet with the World Bank South-South Cooperation team in Cairo, Egypt in September 2010 to validate the proposal, and agree on project implementation arrangements after which the project is expected to launch.

(4) Disaster Risk Management Curriculum Development:

A World Bank mission visited the Alexandria branch of the AASTMT as well as the Regional Centre for Disaster Risk Reduction in Cairo in March 2010, to (i) review and assess current courses at the Academy which could lend themselves to having DRM component integrated; (ii) assess the feasibility of instituting a DRM module; and (iii) to better understand the expectations of the Academy.

The mission recommended designing and implementing an introductory course and a certificate program in DRM for mid-career professionals. The course is expected to provide graduates with a working knowledge and basic capacity to manage disaster risks (see Annex 1).

We would welcome a discussion between the Consultant (Mr. Charles Scawthorn) and the Academy staff to discuss the next steps in the inclusion of DRM modules in the AASTMT curriculum.

(5) Disaster Risk Management and Climate Change Adaptation E-Learning training;

From 22 March to 17 April, 2010, the World Bank Institute provided DRM training which included a "Training the Trainers" component. This was designed to transfer knowledge and capacity to AASTMT experts in the domain of specialized risk management and climate change adaptation. By equipping AASTMT experts with this knowledge, they will be able to independently conduct elearning seminars on these issues in the future to MNA country stakeholders. This training represented the first step toward the transfer of the World Bank e-learning knowledge to the AASTMT.

As a next step, the AASTMT and the MNA DRM team will be offering an online course on comprehensive DRM to regional stakeholders from September 20 to October 24, 2010. To date, 25 participants have enrolled in this AASTMT E-learning course.

(6) Establishment of an AASTMT Branch in Aden (Yemen):

Following the floods that occurred in Yemen in the Hadramout and Al-Mahara Governorates in 2008, the World Bank led a Post-Disaster Needs Assessment (PDNA). As a result of the PDNA, the World Bank is assisting the Government of Yemen to strengthen its national DRM institutions. This includes the development of probabilistic risk studies and risk management strategies at the national, governorate (Hadramout and Al-Mahara) and city (Sana'a) levels. These will enable long-term disaster risk reduction planning and mitigation measures.

Within this context, the MNA DRM Team and AASTMT have been discussing the possibility of establishing a regional branch of the AASTMT in Aden, in order to more effectively support DRM activities in Yemen. A joint mission of the AASTMT and the World Bank is planned for the fall of 2010 to meet the Deputy-Prime Minister for Economic Affairs and Minister of Planning and International Cooperation to discuss and identify future collaboration between the AASTMT and the Government of Yemen.

The South-South Cooperation team is comprised of Mr. Osama Hamad, Senior DRM Specialist and Project Leader & Mr. Andrea Zanon, DRM Specialist.

(7) Establishment of an Arab Disaster Reserve Fund (ADRF):

Disaster risk financing instruments help governments increase their financial response capacities in the aftermath of natural disasters while protecting their long term fiscal balance. An Arab Disaster Reserve Fund (ADRF) would provide Middle East and North African countries with financial coverage against major natural disasters. The Fund would work as a regional reserve fund owned and controlled by the participating countries. Each participating country would pay an annual contribution related to its own risk exposure and would receive a payout in case of a major natural disaster.

In assessing the feasibility of setting up such a Fund, the consultant (Mr. Scawthorn) looks forward to interacting with technical specialists from the Academy and seeking their feedback on the proposed methodology and the hazard and exposure data collection. He is expected to visit AASTMT in Alexandria at least twice: at the beginning of his assignment to present and discuss the scope and methodology and at the end of his assignment to present his findings, Ms. Aditi Banerjee, DRM Analyst, will be leading this engagement on behalf of the World Bank.

(8) Memorandum of Understanding between the AASTMT and the MNA DRM Team:

The MNA DRM team, in partnership with the AASTMT, is completing a MoU formalizing the initiatives on 'capacity building'. The teams envision completing this task by the next GFDRR Result Management Council (RMC) that is taking place in Alexandria, Egypt during the period September 19-20, 2010.


